 - o Group feedback: Suggestion to spread out workers (one worker per island) for more efficient cone work. Suggestion to create a handout with info about where and how to pit, how to work a station, effective course-walking, etc. This would be especially helpful

- With the added 2nd event at Evergreen (9/13), total event count is 7. Discussion about Championship Points and the number of events that can be dropped.
 - o Rules state drivers have to attend at least half of events to be eligible for trophy. With 7 events, drivers must participate in 4 events to be eligible. The odd number also reduces chances of a tie. Without ORP or hillclimbs, drivers would have to do all 4 autocross events.
 - o Do we want to keep the two-drops rule?
 - Suggestion to keep as written (must run 4 events and trophies determined by driver's top 5 scores for the season), keeping in mind that it might have to change if the season gets truncated.
